Will of Henry Bridges, Yeoman, of Churchill, 1694

In the name of God Amen the Eight day of April in the Fifth yeare of the Raigne of our Soveraigne Lord & Lady William & Mary by [th]e grace of God of England Scotland France & Ireland King & Queene

defenders of the Faith [.] Anno dom[ini] 1693 I Henry Bridges of Churchill in the County of Oxon yeoman

being sicke & weake in body but of sound & perfect mind & Memory thanks be given to Allmighty God for

[th]e same doe make & ordaine this my last will & Testam[en]t in manner & Forme Following ( that is to say)

First & most Chieffley I com[m]end my soule to God who gave it: & my body to [th]e earth from whence it

was taken to be decently Interr[e]d att [th]e discrec[i]on of my Executrix herein After named: And as for such

Worldly goods as the Lord in his Infinite mercy hath been pleased to lend me my Will & meaning is that

[th]e same shall be disposed of as by this my Will is express Imprimis I doe give & devise unto my Loving

Sister Dorothy Chapman of Shipton under Whichwood in [th]e County of oxon widdow all & singular my

Wearering Apparrell Item I doe give & devise unto my Kinswoman Mary Chapman daughter of [th]e said

Dorothy Chapman of Shipton under Whichwood Aforesaid the sum[m]e of Five pounds which is due to mee

From Thomas Vabis of Churchill Aforesaid upon Bond: And I doe Further give & devise unto [th]e Aforesaid

Mary Chapman the sum[m]e of six pounds which is due to me from Thomas Reeve of Churchill Aforesd

upon Bond: Together also with two Brass kettles I had of Alice Stockford of Churchill Aforesd: Three pewter dishes Two pewter Flagons one pewter candlestick a little pewter cupp and a chamber pott:

Item all [th]e Rest & Residue of my goods & Chattels not allready disposed of I doe give & devise unto my

deare & loving Wife Elizabeth Bridges whome I doe make & Appoynt [th]e sole Executrix of this my Last Will & Testam[en]t requiring her to perform this my Will in every particular:
