## Will of Mary Clapton, Widow, of Sarsden, 1645

In the name of God Amen I Mary Clapton of Sarsden in [th]e County of Oxon wydow beinge sicke in bodie but of perfecte Memorie thankes be given to God Doe make and ordeyne this my last will & Testament in manner and forme as followeth [viz] First I Com[m]itt my soule into the hands of Almighty god hopinge to be saved by the merritte of Jesus [Chris]te And my body to be buried in the Parish Church of Churchill in the County of Oxon Item I doe give and bequeath unto my daughter in law Ursula Harris of London one gowne the bodyce and kirtle thereunto belonginge w[hic]h of my gownes my Executrix shall please and one petticoat and a roughbande Item I doe give and bequeath unto Judith Harris daughter of the said Ursula Harris one gowne & bodyce & kirtle thereunto belonginge and one Petticoate and one Roughbande Item I doe give and bequeath unto Mary Crosse the daughter of my son in law John Crosse one Cow Item I doe give and bequeath unto Robert Crosse the son of the fores[ai]d John Crosse one Cow Item I doe give and bequeath unto Richard Crosse the son of the aforesaid John Crosse one cow Item I doe appoynte and ordeyne Alice Crosse the wife of my son in law John Crosse of Sarsden to be Executrix of all my goods Chatteles Cattell moveables and unmovables whatsoever I have w[it]hin the County of Oxon or elsewhere And doe make her my sole Executrix Item I doe give and bequeath unto Franncis Crosse son of the s[ai]d John Crosse afores[ai]d The sume of Five pounds of Lawfull money of England to be paid unto him w[it]hin halfe a yeare next after my deceasse Item I doe intreat my neighboure Thomas Beard and Thomas Dines to be Overseeres of this my last will & Testament. In wittnes wherof I have caused this my last will & Testament to be made and hath hereunto sett my hande & seale the Thirteenth day of Aprill in the yeare of o<sup>ur</sup> Lorde god one Thousand Sixe hundred Fourty & three And in the Nyneteenth yeare of the reigne of o<sup>ur</sup> sovreigne Lorde Charles by the grace of god of England Scotland France & Ireland Kinge defender of [th]e faith [etc] Item I doe give and bequeath unto Edmund Glynn of Churchill cleark three shillinge & foure pound It[e]m do give unto the overseeres of this my will Five shillings a peece.
