Will of Morris Mullington, husbandman, of Churchill, 1585

In the name of god amen I morris mullington of Churchill in this countie of Oxford husbandman beinge sicke in bodie never the lesse of good & perfect remembrance god be thanked, doe make this my last will & testament in manner & forme followinge first I bequeathe my soule to almightie god my maker & redemer & my bodie to the grounde from whence h it was taken to be buried in the churcheyard of Churchill aforesaide It[em] I give unto the mother churche in Oxford ii d It[em] I geve unto Wyll[ia]m mullington my sonne the iron baril the great pott the overwhart sawe & the malt miln & the whiche my will is shalbe delivered after the decease of Ales my wife and in the meane time thye to use them together as here tofore they have donne It[em] I geve unto my sonne Wyll[ia]m his three children Morris Anne & Wyll[ia]m everie one of the[m] a sheepe to be delivered immediatlye after they be shorne It[em] I geve unto Tho[mas] my sonne my iron bound cart my seston a garner <sup>1</sup> for corne the best pan the hand sawe and all my awgers to be delivered after the decease of Ales my wife It[em] I give unto doritie Mullingto[n] my sonne Thomas his daughter one sheepe to be delivered after hit is is shorne It[em] I geve unto Jhon mason ij sheepe to Tho[mas] mason ij sheepe to Simon mason one sheepe to Tho[mas] mason the yonger one sheepe to be delivered after they be shorne It[em] I geve unto Francis Perin one tagged heifer to Tho[mas] Perrin one sheepe It[em] I give unto Tho[mas] Perrin the elder one curnocke<sup>2</sup>
