I John Rawlins of Sarsden in the County of Oxon yeoman being of perfect mind and memory Praise be given to God do ordaine and appoint this my last will and Testament in manner and forme following Inprimis I Committ my soule into the hands of Almighty God my Creator and Redeemer Through the meritts of my Saviour Christ Jesus And my body to the Earth in hopes of glorious resurrection And for my Estate I dispose of as followeth Item I give to Judith Kerry my daughter the Sum[m]e of Twenty shillings Item I give to my brother Thomas Rawlins the Sum[m]e of Five pounds And Item I give to Francis Rawlins my brother the Sum[m]e of Five pounds Item I give to my daughter Anne Humphreyes the Sum[m]e of Tenn shillings Item

Item I give to my Grandchild John Humphreys the Sum[m]e of Tenn shillings Item I give to my Grandchild Mary Humphreys the Sum[m]e of Tenn shillings Item I give to my Grandchild Margarett Kerry The sum[m]e of Five pounds Item I give to my Cosen Thomas Ansteed the sum[m]e of Forty shillings Item I give to Elianor Stayt The sum[m]e of Twenty shillings Item I give to the poor of Sarsden the sum[m]e of Twenty shillings shillings Item for all the rest of my goods Cattell and Chattells I give to Sonne John Rawlins And for the Executing of this my will I doe ordaine and ap~ poynt my sonne John Rawlins to be my Executor And in Case my Executo[r] John Rawlins Shall dye before that he should prove my will according to due Course of Lawe Then my will is That the Legacie given to my sonne John Rawlins shall goe to the use and benefitt of my Three Grandchildren Margarett Kerry John Humphreys and Mary Humphreys joyntly to be di= vided between them And then I doe ordeyne my Two Cosens Tho= mas Hacker and John Hacker of Churchill To be Executo[rs] of this my last will and Testament And I doe give to each of them Five shillings a -

peece to buy them Gloves In witness whereof I have hereunto sett my hand and seale the Twenty Eighth day of December Anno Domini One Thousand Six Hundred Sixty Eight , the marke of John Rawlins. Sealed and declared in the p^[re]sence of Jeremiah Norgrove Thomas Kerry Es: Hacker.
